BLUE RIBBON PRIVATE TREATY HORSE SALE

**DEADLINE TO ENTER HORSES INTO THE BLUE RIBBON SALE IS MARCH 15, 2024.
REGISTRATION FEE INCREASES FROM \$175.00 TO \$225.00 AFTER MARCH 15, 2024.**

Please submit sale-quality pictures in .JPG format with your registration. You can also include a link to any YouTube video(s) you have showcasing your horse. To ensure the information on your horse and any photo(s) you submit get placed on the Expo website and Facebook page, please register by the March 15, 2024 deadline.

Blue Ribbon Horse Sale will provide:

- ◇ Stall in our Horse Sale Barn for 3 days with 3 bags of bedding. Any other bedding can be purchased from our Blue Ribbon Hosts. The stalls for the Blue Ribbon Sale horses are located in the stall row barns, just a short walk from the Expo building.
- ◇ Advertising on our Expo website and Facebook page (photo, breed, age, gender, name, discipline, and price).
- ◇ Handouts given to potential buyers will include the description you provided in your registration.
- ◇ Our Blue Ribbon Hosts will be on-site to point potential buyers to horses they are looking for.
- ◇ Round pen for test rides (18 & over) on broke and safe horses (signed release required). Ride times TBA.
- ◇ A veterinarian can be available for a pre-purchase vet check (not a free service).
- ◇ You will receive a Blue Ribbon for your horse to wear while out of the stall.
- ◇ Tack stalls can be rented next to your horse(s) for an additional \$25/day or you can keep your items in your horse trailer.
- ◇ Brand inspection for sales (cost applies, payable to the State Brand Office) will be on site.
- ◇ Allotted time to show your horse in the main arena during Expo schedule and round pens.
- ◇ Admission for 2 for 3 days.

Horse owner will provide:

- ◇ \$175.00 fee for 12x12 stall (**fee increases to \$225.00 for entries submitted after March 15, 2024 deadline.**)
- ◇ Information on the horse for placement on the Expo website and Facebook.
- ◇ Quality picture(s) of horse(s) in .JPG format.
- ◇ Negative Coggins and health certificate dated within 30 days of Expo start date.
- ◇ Signed release and horse entry form.
- ◇ Horse(s) to be presented as sound. Any issues must be disclosed.

A Few More Pointers & Rules

- ◇ Seller has the right to sell the horse at Private Treaty and lower the asking price.
- ◇ Horses unhandled or unsafe are not allowed at sale.
- ◇ Horses with any type of communicable disease are not allowed at sale.
- ◇ Horses in unkempt and ungroomed condition (untrimmed hooves, unbrushed coat, etc.) are not allowed at sale.
- ◇ Owner or representative warrants ownership to each consigned animal herein entered and agree to defend said ownership against all adverse claims.
- ◇ Owner will provide signed breed papers, if they apply, at sale of horse.
- ◇ Owners agree to hold Idaho Horse Expo, and its agents, harmless from any cost of liabilities that might occur during the stay at the Horse Park.
- ◇ Horse owners are encouraged to contact their insurance company to arrange for appropriate insurance to present horse(s) in public.
